

POLITIQUE ÉTRANGÈRE

Instructions for authors

Politique étrangère is a journal of debate and analysis on major international issues. It is the oldest French journal in this field.

Its purpose is to highlight all aspects of the debate in international relations, to propose in-depth analysis of current affairs and to be a reference tool on a long term basis for academic circles, decision-makers and the civil society.

Each issue includes one section related to an event or a dimension of international debate and also several articles focusing on deciphering topical issues.

1. MANUSCRIPT SUBMISSION

Submitted manuscripts must be the product of an original work not subject to a previous publication. These texts are anonymously evaluated by peers, in a system of multiple reading. Readers may be either members of the editorial board or external people, French or not, all selected for their competence.

2. MANUSCRIPT

Politique étrangère publishes articles in French and English. Submitted manuscripts must have 30 000 characters including spaces and footnotes. They must be composed of the following elements:

2.1 Title page

- A title in French
- A biography of the author (3-4 lines maximum)

- An abstract in French (450 characters maximum)

2.2 Body of the manuscript

Authors must make sure that submitted manuscripts are easily understandable and both concise and precise. Manuscripts must be written in clear understandable language (French or English).

Abbreviations can be used and must be explained in full at first use in the text. Further use of an abbreviation must be coherent and invariable. Abbreviations are to be avoided in the title and abstract.

Use French quotation marks for all citations. Foreign words and book titles only are in italics.

2.3 References

All references must be cited in footnotes and must be formatted according to French typography.

3. EDITING, PROOFS, REPRODUCTION

When a manuscript has been accepted for publication, the author is requested to complete a document transferring the copyright to the publisher. This document must be completed and signed by the author and returned to Ifri as soon as possible. The author will receive one copy of the book upon publication.

The corresponding author will receive electronic proofs in PDF format. Modifications must be limited to correction of typographical errors.

The authors will return the corrected proofs to the publisher as soon as possible, within 3 days of reception throughout the year. The publisher reserves the right to proceed with publication should the author fail to respond within the allotted delay.

After publication, all requests for reproduction must be addressed to Ifri.
